I am so grateful that the NNA has an award like the Daniel M. Phillips Leadership Award to present to young leaders in our community who help promote our industry and the audiences we serve. I am pleased to nominate Michael Smith, a professional who exemplifies the highest standards of leadership.

I am enclosing a brief list of Michael's accomplishments. It speaks well about his professional qualifications.

But that's not the reason I am nominating him.

I am putting Michael up for consideration because of the impact he has as editor of the Carolina Forest Chronicle on the community he serves.

Carolina Forest is thriving community located west of Myrtle Beach, S.C. in an unincorporated part of Horry County. In 2007, it was a hodgepodge of subdivisions containing 13,000 homes. Other than a few home owners associations, the area did not have an advocate in government.

Realizing the importance of have a strong presence at the local and state level, Smith reached out to members of the various Carolina Forest subdivisions and encouraged them to attend a series of meetings to discuss forming a civic association. He presided over nearly a dozen meetings, publicized the events in the Chronicle, and provided editorial support for the events. Thanks to his efforts, the civic association was formed in 2009.

Since then, the Carolina Forrest Civic Association has grown membership and become a force to deal with in county and state government. New roads, a new library and greater representation in the S.C. General Assembly are just a few of the accomplishments made since the association formed.

In typically modest form, Michael declined offers to be the civic association's first president. He did so to avoid any conflict of interests, since he reports on the association's monthly meetings. Nevertheless, Michael continues to support the organization's with stories and editorials.

Would a community of 13,000 homes eventually form a civic association anyway?

Perhaps. Irregardless, it takes someone with vision and leadership to get the ball rolling, Smith showed tremendous vision in seeing the need and then providing the leadership needed to get the job done!

For this reason, as well as his many other accomplishments as a journalist, I think Smith is the perfect candidates for the Daniel M. Phillips Leadership Award.

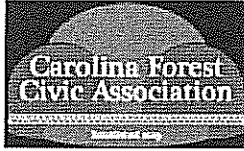
